

ANIMAL FARM FOUNDATION ASSISTANCE DOG TRAINING PROGRAM



The mission of Animal Farm Foundation is to secure equal treatment and opportunity for “pit bull” dogs. In an effort to meet that mission, Animal Farm Foundation has established an Assistance Dog Training program where “pit bull” dogs in animal shelters and rescues can be considered for the same work traditionally reserved for pure bred, purpose bred dogs.

Animal Farm Foundation is accepting submissions for our Assistance Dog Training Program. Dogs accepted into our program will be transported to Animal Farm Foundation at our own expense. Ownership of the dog must be transferred to Animal Farm Foundation for training to occur. The dog will be trained by a Certified Assistance Dog Trainer and matched with a client who meets the requirements established by the Americans with Disabilities Act (ADA) for assistance dog eligibility. All dogs and clients will receive training support for the duration of the match.*

There is no cost to the client for the dog or for the support training.

TO BE ELIGIBLE:

- The dog must be homeless and residing in a shelter or rescue.
- The dog must be a “pit bull” dog.**
- The dog must be physically sound with good bone structure.
- The dog should have an estimated age between 15 months and 3 years.

REQUIREMENTS:

- The dog must be tolerant with all handling that may be done by the client including nail trims, teeth cleaning, ear cleaning, grooming, etc.
- The dog must tolerate the presence of all other animals, of any kind.
- The dog must be tolerant of all people.
- The dog must demonstrate a desire to work.



Note: Dogs who are reactive in any way, regardless of the reason or circumstances, are not eligible.

**All dogs accepted into our program will have a lifetime commitment from Animal Farm Foundation. Any dogs who do not succeed as assistance dogs will be moved to our adoptions program to be placed as a companion pet. Any dogs who, after being trained, matched and placed, are returned to Animal Farm Foundation will be reevaluated and either placed with a different client or moved to our adoptions program.*

*** What shelters and rescues consider a “pit bull” dog varies significantly from place to place. If the shelter or rescue staff labeled the dog a “pit bull” at intake, the dog is eligible for consideration.*

SUBMISSIONS:

Please include the following:

- Any and all known health and medical information (official shelter/vet/rescue records).
- Any and all known behavioral history of the dog, in detail.
- A video that shows the dog experiencing the entire standard evaluation used by your shelter or rescue; if your organization does not have an evaluation, please contact a local professional who can complete an evaluation for you. If not included in the standard evaluation, please include:
 - Dog in a kennel or crate with strangers approaching one at a time (an adult female, an adult male, and then a child).
 - On-leash greeting of a dog of the opposite sex first, then a dog of the same sex.
 - Resource guarding test (dry food, wet food, and rawhide).
 - Resource guarding and arousal recovery test (ball, tug, and squeaky toy).
 - Dog in a city-type environment with pedestrians, vehicles, noise, etc.
 - Dog's reaction to loud noises, such as the doorbell and a smoke alarm.
 - Dog showing a desire to work for food.

Submissions are accepted electronically or by mail.

If submitted electronically, the video should be saved to a video sharing account. The link and password to the account should be included in an email with the other required information attached. The attachments must be scanned copies of the original paperwork. No copied and pasted information will be accepted.
